General Public License**

**PLEASE READ THIS LICENSE AGREEMENT (“LICENSE”) CAREFULLY BEFORE USING THE GIS DATA CONTAINED ONLINE. BY USING THE DATA, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT USE THE DATA.**

**IMPORTANT: This GIS Data is not intended for use in the operation of aircraft navigation, emergency communication systems, air traffic control systems, or in any other application in which the failure or inaccuracy of the data could lead to death, personal injury, or any other damages whatsoever.**

**1. General.** The GIS data and any accompanying documentation, in any medium whatsoever (collectively the “GIS Data”) are licensed, not sold, to you by Dauphin County for use only under the terms of this License, and Dauphin County reserves all rights not expressly granted to you. The rights granted herein are limited to Dauphin County and its licensors' intellectual property rights in the GIS Data and does not include any other patents or intellectual property rights. Dauphin County retains ownership of the GIS Data itself. The terms of this License will govern any GIS Data upgrade provided by Dauphin County that replaces and/or supplements the original GIS Data, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

**2. Grant of License.** This License allows you to install, use, modify, and convey the GIS Data contained online subject to the terms and conditions set forth in this License Agreement. Dauphin County hereby grants to you during the Term of this License Agreement, and you hereby accept from Dauphin County, a revocable, limited, non-exclusive license to install, use, modify and/or convey the GIS Data. The licenses granted under this Agreement are specifically set forth herein, and no other licenses are granted by Dauphin County to you by implication or estoppel. At all times, the GIS Data shall remain the property of Dauphin County.

**3. Permitted Uses.** In addition to your own use of this GIS Data pursuant to the terms and conditions hereof, you may also (a) make derivative works from this GIS Data, (b) incorporate this GIS Data into another product, and (c) make a transfer of all of your license rights to the GIS Data to another party, provided that all of the terms of this license agreement, including but not limited to all of the restrictions, disclaimers of warranties, and limitations of liability set forth herein, are made to inure to any and all subsequent purchasers, users or licensees of said products or works which contain this GIS Data. You are responsible to insure that any third party receiving this GIS Data from you, in whole, in part, or apart of another application, must agree to accept the terms and conditions of this License.

**4. Additional Conveyance Provisions.** Each time you convey the GIS Data the recipient automatically receives a license from the original licensors, to run, modify and propagate the GIS Data, subject to this License. Each party to such a transaction who receives a copy of the GIS Data also receives whatever licenses to the GIS Data the party's predecessor in interest had or could give under the previous

paragraphs, plus a right to possession of the GIS Data from the predecessor in interest, if the predecessor has it. If you cannot convey the GIS Data so as to satisfy simultaneously your obligation under this License and any other pertinent obligations, then you may not convey. Upon a conveyance, you may not impose any further restrictions on the exercise of the rights granted or affirmed under this License such as, but not limited to, a license fee, royalty, or other charge. You may not initiate litigation (including a cross-claim or counterclaim in a lawsuit) alleging that any patent claim is infringed by making, using, selling, offering for sale, or importing the GIS Data or any portion of it. You are responsible for enforcing compliance with this License by third party conveyees.

**5. Reservation of Rights.** Dauphin County reserves the right to change, suspend, remove, or disable access to any GIS Data at any time without notice. In no event will Dauphin County be liable for the removal of or disabling of access to any such GIS Data. Dauphin County may also impose limits on the use of or access to certain GIS Data, without notice or liability.

**6. Termination.** This License is effective until terminated. Dauphin County may terminate this License at any time without notice. Your rights under this License will terminate automatically without notice from Dauphin County if you fail to comply with any term(s) of this License. Upon the termination of this License, you shall cease all use of the GIS Data and destroy all copies, full or partial, of the GIS Data.

**7. Disclaimer of Warranties.** YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT USE OF THE GIS DATA IS AT YOUR SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY AND EFFORT IS WITH YOU. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THIS GIS DATA IS PROVIDED "AS IS", WITH ALL FAULTS AND WITHOUT WARRANTY OF ANY KIND, AND DAUPHIN COUNTY HEREBY DISCLAIMS ALL WARRANTIES AND CONDITIONS WITH RESPECT TO THE GIS DATA, EITHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, OF SATISFACTORY QUALITY, OF FITNESS FOR A PARTICULAR PURPOSE, OF ACCURACY, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. DAUPHIN COUNTY DOES NOT WARRANT AGAINST INTERFERENCE WITH YOUR ENJOYMENT OF THE GIS DATA, THAT THE FUNCTIONS CONTAINED IN THE GIS DATA WILL MEET YOUR REQUIREMENTS, THAT THE OPERATION OF THE GIS DATA WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT DEFECTS IN THE GIS DATA WILL BE CORRECTED. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY DAUPHIN COUNTY SHALL CREATE A WARRANTY. SHOULD THE GIS DATA PROVE DEFECTIVE, YOU ASSUME THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

**8. Limitation of Liability.** TO THE FULLEST EXTENT NOT PROHIBITED BY LAW, IN NO EVENT SHALL DAUPHIN COUNTY BE LIABLE FOR PERSONAL INJURY, OR ANY INCIDENTAL, SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF PROFITS, LOSS OF DATA, BUSINESS INTERRUPTION OR ANY OTHER COMMERCIAL DAMAGES OR LOSSES, ARISING OUT OF OR RELATED TO YOUR USE OR INABILITY TO USE THE GIS DATA, HOWEVER CAUSED, REGARDLESS OF THE THEORY OF LIABILITY (CONTRACT, TORT OR OTHERWISE) AND EVEN IF DAUPHIN COUNTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL DAUPHIN COUNTY'S TOTAL LIABILITY TO YOU FOR ALL DAMAGES WHICH CANNOT BE DISCLAIMED OR WAIVED (UNLESS OTHERWISE REQUIRED BY APPLICABLE LAW) EXCEED THE AMOUNT OF FIFTY DOLLARS (\$50.00). THE FOREGOING LIMITATIONS WILL APPLY EVEN IF THE ABOVE STATED REMEDY FAILS OF ITS ESSENTIAL PURPOSE.

**9. Indemnification.** You agree to indemnify and hold harmless Dauphin County, its Commissioners, administrators, directors, officers, employees, and agents from and against any and all claims, actions, or liabilities of any nature that may be asserted against Dauphin County by third parties in connection with the use or dissemination of the GIS Data licensed under this Agreement.

**10. Export Control.** You may not use or otherwise export or re-export this GIS Data except as authorized by United States law and the laws of the jurisdiction in which the GIS Data was obtained. In particular, but without limitation, the GIS Data may not be exported or re-exported (a) into any U.S. embargoed countries or (b) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce Denied Person's List or Entity List. By using the GIS Data, you represent and warrant that you are not located in any such country or on any such list. You also agree that you will not use the GIS Data for any purposes prohibited by United States law, including, without limitation, the guidance, development, design, manufacture or production of missiles, or nuclear, chemical or biological weapons.

**11. Controlling Law and Severability.** This License will be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania, as applied to agreements entered into and to be performed entirely within Pennsylvania between Pennsylvania residents. This License shall not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. If for any reason a court of competent jurisdiction finds any provision, or portion thereof, to be unenforceable, the remainder of this License shall continue in full force and effect.

**12. Complete Agreement; Governing Language.** This License constitutes the entire agreement between the parties with respect to the use of the GIS Data licensed hereunder and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by Dauphin County. Any translation of this License done by you for local requirements shall result in the event of a dispute between the English and any non-English versions, the English version of this License governing.

**13. Notice of Data Discrepancies.** Within ten (10) days of discovery, you must notify Dauphin County of any discrepancies in the GIS Data. All discrepancies are subject to verification by Dauphin County prior to change in the GIS data set and Dauphin County shall not have obligation to you or any other entity to resolve any such discrepancies.

**14. Notification of Infringement.** If you become aware of the unauthorized use, copying, or disclosure of the GIS Data, you must notify Dauphin County within three (3) business days and you shall assist Dauphin County, at Dauphin County's request and expense, in the investigation and prosecution of such unauthorized use, copying, or disclosure.

**15. Technical Assistance.** Dauphin County shall not be responsible or in any way obligated to provide technical support to you or any other party regarding the use of this GIS data.

**16. Licensee Software.**

You shall be solely responsible for the license, acquisition and/or maintenance of whatever software and computer hardware is necessary to utilize the GIS Data provided hereunder.

**17. Remedies.** It is further understood and agreed that money damages may not be a sufficient remedy for any breach of this Agreement by you and that Dauphin County shall also be entitled to specific performance as a remedy for any such breach. These remedies shall not be deemed to be the exclusive

remedies for breach of this Agreement, but shall be in addition to all other remedies available at law or equity to Dauphin County.

**18. Public Attribution.** You agree that any dissemination or publication, either written or electronic, or any public pronouncement that focuses upon any topic that incorporates Dauphin County's GIS Data as licensed hereunder shall include an acknowledgement of "Dauphin County" and its role in providing the GIS Data.

**19. Strict Enforcement.** The delay or failure of Dauphin County to strictly enforce any provision of this Agreement will not bar Dauphin County from any subsequent enforcement of any right, remedy or legal cause of action.
